I have the honor of addressing you, regarding to the 11<sup>th</sup> Scientific Meeting of the South Pacific Regional Fisheries Management Organization (SPRFMO), to be held in Panama from September 11 to 16, 2023.

Based on the aforementioned, we inform that we have made the inquiries corresponding to the visa required by the Members for this Meeting and the National Immigration Service has informed that the delegations that require a visa to enter Panama are the following:

- Republic of Cuba.
- People's Republic of China.
- Republic of Liberia.

The procedure to follow for the visa application for each country is as follows:

Republic of Cuba	The participant must present at the Panamanian Embassy or Consulate in Cuba, when notified, with all the requirements for the visa application, which are found on the website of the National Migration Service. Republic of China	The participant must present at the Panamanian Embassy or any of our Consulates in the People's Republic of China, with all the requirements to apply for the visa. Republic of Liberia	The participant must go to the Panamanian Embassy or Consulate in Morocco, with all the requirements for the visa application, which can be found on the website of the National Immigration Service. Or Consult your Ministry of Foreign Affairs or their Diplomatic Mission with presence in Morocco, which would be the procedure. It is important to point out that all the requirements and the visa form must be accompanied by the invitation note to the meeting and indicate to the official who will attend you at the Diplomatic Mission that you will be participating in the Scientific Meeting hosted by the Republic of Panama.

It is required to send us as soon as possible the name(s) of the participant(s), a copy of the passport in color with all its general information, and if the participant has an American visa, used during the last 6 months to travel to Panama, it will be opportune to receive a copy of said document.
